

"Dream" Song Video Project Waiver and Release Form
(Each and Every Cast and Crew Member Must Sign and Submit)

I, _____, and each of my heirs, next of kin, spouse/spousal equivalent, guardians, legal representatives, executors, administrators, successors and assigns (collectively, "the Releasing Parties"), agree to participate by submitting a video ("Video Submission") in connection with a motion picture/video/film being produced by Maestro ARD Ltd ("Filmmaker") as part of the "Dream" Song Video Project for Alison Lorraine on _____ (date) ("the Project"), as well as in connection with any footage, recordings taped, filmed, recorded or otherwise produced with regard to the Project ("Footage").

I hereby grant Filmmaker and Alison Lorraine and their respective parents, affiliates, subsidiaries, representatives, partners, shareholders, employees, contractors, licensees, assigns and members of each of the foregoing entities (together, "the Released Parties"): (a) the right, but not the obligation, to include my Footage in the Project, as well as any pre-existing materials furnished by me in and in connection with the Footage; (b) all rights of every kind and character whatsoever (including, without limitation, copyrights) in and to the results and proceeds of my appearance(s) in the Footage, including, without limitation, all film, photographs, video and audio recordings produced by the Filmmaker and Alison Lorraine in connection therewith (collectively, "Recordings"), any and all performances, stories, statements or actions made by me, whether written, spoken, sung or otherwise uttered or expressed by me, or information given by me, captured on any such Recordings (collectively, the "Results and Proceeds").

Filmmaker and Alison Lorraine shall be the exclusive owner(s) of the Footage and of the Results and Proceeds, giving them the right to, without limitation, in perpetuity throughout the universe, in any and all languages, in any and all media known or hereafter invented: (a) exhibit, broadcast, use, reproduce and license others to use as they see fit all or any part of Footage and/or the Results and Proceeds; (b) use and license others to use my name, likeness, image, voice, performance, photograph, participation, expressions, personal experiences and biographical material (together, "Name and Likeness"); and (c) edit, dub, subtract from, add to or modify the Results and Proceeds in any manner, combine it with any other material and/or integrate it into other projects, films, videos, or programs, in and in connection with the production, distribution, advertising, promotion, publicity, exhibition and other exploitation of the Footage, the Results and Proceeds, and/or any portion thereof and in connection with Filmmaker and Alison Lorraine's products and services, an unlimited number of times, without any obligation of any kind to me whatsoever, and I hereby waive any and all "moral rights" or "droits morale" in connection with the Footage, Results and Proceeds.

I warrant that my Video Submission and appearance in the Footage will not, to the best of my knowledge, infringe upon the rights of any third party, and that I have all rights and authority to enter into this Waiver and Release and to grant all rights herein.

I voluntarily assume any and all risks, known or unknown, associated with my participation in the Project, including, but not limited to, creation/production/submission and subsequent use, exploitation or dissemination of any and all associated Footage, including pre-existing materials. I knowingly and voluntarily release and discharge and relinquish any and all claims, actions and lawsuits of any kind against the Released Parties related to or arising from my participation in the Project. I also acknowledge that I may hereafter discover claims in addition to the ones released herein, and I and the other Releasing Parties hereby release the Released Parties from any such unknown and/or unsuspected claims, and that without signing this Waiver and Release, my participation in the Project would not be accepted by the Released Parties. I and the other Releasing Parties warrant that we have been advised by legal counsel, or have been given ample opportunity to be so advised in relation to this Waiver and Release. This release shall bind and inure to the benefit of the parties hereto and any and all of their respective assigns. I acknowledge that Alison Lorraine and Filmmaker will rely on the Waiver and Releases and permissions granted herein at potential great cost and hereby agree not to assert any claim of any nature whatsoever against anyone relating to the exercise of the permissions granted hereunder.

This Waiver and Release shall be subject to the laws of the state of Nevada. Should any provision herein be found invalid, in whole or in part, it shall not affect the validity or enforceability of any other provision herein.
